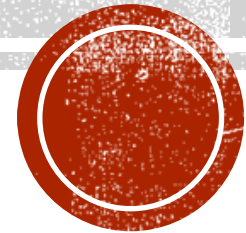

INTELLECTUAL PROPERTY CORPORATION OF MALAYSIA

- Known also as MyIPO
- Statutory body under the Ministry of Domestic Trade and Consumer Affairs since March 3, 2003
- Main function is to establish a strong and effective administration of Intellectual Property Legislation in Malaysia

ACTS UNDER MYIPO

- Intellectual Property Corporation Act 2002
- Patents Act 1983
- Trademarks Act 2019
- Industrial Design Act 1996
- Geographical Indication Act 2000
- Copyrights Act 1987
- Integrated Circuits & Layout Designs Act 2000



NEW TRADEMARKS ACT 2019

- Previous Trade Marks Act 1976 has been abolished and replaced with new Trademarks Act 2019.
- Previous act based on old UK Trade Marks Act 1938.
- Not suitable for current business environment.
- New Trademarks Act gazette in 9 December 2019 and enforced in 27 December 2019.
- Includes new features and simplifies current processes.



TRADEMARKS ACT 2019 SALIENT POINTS

- Expanded scope of definition
- Inclusion of non-traditional trademarks
- Simplification of registration process
- Accession to Madrid Protocol
- Etc. (expanded scope of border measure protection, TM as collateral,...)



EXPANDED SCOPE OF DEFINITION

- “Sign” includes the following or any combination of the following, namely, any letter, word, name, signature, numeral, device, brand, heading, label, ticket, **shape of goods or their packaging, colour, sound, scent, hologram, positioning, sequence of motion;**
- • Refer: Para. 3 of GTM 2019 for examples



TYPES OF TRADEMARKS

- Word
 - Device
 - Combination of Word and Device
 - Stylized Word
 - Shape of goods or packaging (3D Mark)
 - Colour
- Sound
 - Scent
 - Hologram
 - Positioning
 - Sequence of Motion
 - Any combination mentioned



TYPES OF TRADEMARK APPLICATION

TRADEMARK

- Normal application
- Individual and Companies

CERTIFICATION MARK

- A mark used for certifying others
- Usually applied by government agencies / authorities

COLLECTIVE MARK

- Similar to normal application
- Used by organization or society



NEW APPLICATION PROCESS

- Normal Route
 - TMA2 – Application for registration of Trademark
 - RM 950 (for each class adopting pre-approved list)
 - RM 1 100 (for each class without adopting pre-approved list)
 - RM 50 (for subsequent series of trademark)
- Expedited Route
 - TMA4 – Request for expedited examination of a trademark application
 - RM 1000 (for each class)
- No need for SD (statutory declaration)
- No staggered fees



MADRID PROTOCOL

- Administered by the World Intellectual Property Organization (WIPO). As of December 2019, the Madrid System has 106 members, which represents 122 countries.
- Filing a single application in one language and by paying one set of fees a trademark owner can apply for protection in over 122 countries through MyIPO as Office of Origin.
- Also allows for the renewal, or expansion of global trademark portfolio through one centralized system.

WAIVER OF FEES FOR IP

- **Trademarks (Waiver and Modification of Fee) Regulations 2020, 30 December 2020**
 - **Waiver of fee:**
 - Request for waiver of fee made in period of 1 January 2021 – 30 June 2021
 - Individuals under B40 categories, organizations which qualify
 - For matters of amendments to the applicant's name or address, time extension applications and proceedings, and manual filings of documents
 - **Modification of fee:**
 - For Trademarks expiring within period of 1 January 2021 – 30 June 2021
 - Request for modification of fee made within 6 months of expiration date of granted Trademark
 - Individuals under B40 categories, organizations which qualify



WAIVER OF FEES FOR IP

- **Patents (Waiver of Fee) Regulations 2020, 30 December 2020**
 - For Patents and Utility Innovation expiring within period of 1 January 2021 – 30 June 2021
 - Individuals under B40 categories, organizations which qualify
 - Accompanied with payment of annual fee within grace period of 6 months pursuant to subsection 35 (2) and 35 (4) for affected Patents and Utility Innovation

ENABLING INNOVATION ENVIRONMENT (EIE)

WHAT?

- Is a project implemented by WIPO to increase the capacity for innovation support by helping to build the IP components of local innovation ecosystem through university innovation technology support offices and WIPO's Technology and Innovation Support Centres (TISC) network.
- It is a long term project with a time frame of 6-7 years and funded by WIPO-Japan Funds in Trust.

OBJECTIVES:

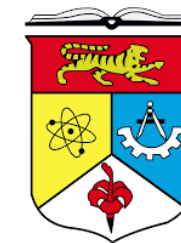
- Support universities/research institutions by strengthening their IP and related competencies in technology development, management and commercialization using appropriate tools, skills and knowledge;
- Strengthen university-industry collaboration through linkages, partnerships and collaboration for technology commercialization; and
- Establish a networked community of technology professionals with IP and other related skills and knowledge.



EIE SPOKES

The EIE Project in Malaysia started in year 2016 with the Hub and Spokes model. MyIPO as the Hub in Malaysia acts as the coordinating body between WIPO and the 7 institutions in Malaysia that was chosen as the Spokes. The 7 Spokes are:

- i. Universiti Malaya (UM)
- ii. Universiti Sains Malaysia (USM)
- iii. Universiti Putra Malaysia (UPM)
- iv. Universiti Kebangsaan Malaysia (UKM)
- v. Universiti Teknologi Malaysia (UTM)
- vi. Forest Research Institute of Malaysia (FRIM)
- vii. Malaysian Palm Oil Board (MPOB)



EIE REMOTE MENTORING PROGRAM

- Managers from selected Spoke institutions, were selected to participate in a pilot 6-month direct assistance technology-based remote mentoring program with WIPO experts.
- Involves remote (i.e., via video-conference, email, electronic document exchange) advisory services.
- Focuses on IP management, commercialization, and licensing of selected Spokes' technologies, and includes counseling on technology transfer policies and operations.

Objectives:

- To provide tailored guidance and capacity-building support for selected TTOs in the assessment, planning and commercialization of selected inventions from their institution.
- To provide a vehicle for supplemental support and assistance in addressing ancillary issues routinely faced by TTOs in the course of their normal work

MYMARK

- MYMARK is a collaborative programme between MYNIC Berhad and MyIPO that enables trademark owners to secure their digital brandings from an unauthorized use and cybersquatting. MYMARK allows an applicant for registration of trademark or registered proprietor of trademark to register up to five (5) .MY domain names such as “.com.my”, “.my”, and “.org.my”.
